DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached building, five bays wide and two bays in depth, with a large concrete block extension to the rear. This is either an old Federal building with new brick walls or a newer building in the proportions and shape of the Federal style. The three exposed sides are laid in unpainted Flemish bond brick. The front facade has no resemblance to Federal as the central entrance-way and adjoining windows are enclosed by cast cement trim giving this building classic styling. The roof of the front section is of a steep "A" frame construction and appears to have a slate covering. The sidewalls are built up to form curtains with end buttresses. On each gable are enclosed square chimneys, not of Federal shape. The front facade is topped by a concrete moulded cornice and frieze. This same material is used for the doorway surround and window lintels and sills.
