DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick pair of houses detached on the left side and which is four bays wide by approximately five bays in depth with a two story brick "T" shaped wing three bays wide and four bays deep, which may be older than the front section. A rear balcony remains at #230. The front facade has a hard pressed brick facing and all is in common bond with the front recently restored. The left wall contains star ending plates for building braces. Front entranceways occupy the outer bays with round arched double doors leading to vestibules. These have transoms and round three row brick header arches, as do the wide 1/1 sash windows in the inner bays. The doorways have marble sills and are approached by three step brick porches with wrought iron railings. The second floor front outer bays have large bay windows trimmed by moulded cornices, a row of dentils, fluted pilasters, and recessed panels. These are of 1/1 sash as are the narrow, round arched windows in the inner bays. Wing windows are of 2/2 or 1/1 sash with two row header segmental arches and some have louvered shutters. The front section roof slopes to the rear and the wing has a low "A" frame roof with both of metal. The front roofline has a Victorian cornice, rich with moulding, and a top band of incised crosses. Both the front section and the wing rests on high fieldstone foundations. There are long yards to the rear.
