DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached old Federal home now altered into a tavern. It is four bays wide and two bays in depth with an "L" shaped two story brick wing approximately five bays long and two bays wide with a side balcony and a one story, one bay square extension. All brickwork is in common bond. The first floor front has been entirely rebuilt with the old doorway moved to the center and surrounded by glass brick windows. The second story has 2/2 sash windows on the front and rear with wood lintels and sills and louvered shutters, and the wing has 6/6 sash with wood lintels and sills. There is a four panel door with an overlight on the rear area. The attic is lighted by 4/2 sashes in each gable. The front section has a steep slope "A" frame roof resting on a three string brick cornice on the front and the rear has a two string cornice. A double flue enclosed chimney rises from each gable. The wing has a shed roof and both are of metal. The building rests on a street level fieldstone foundation and is fronted by a herringbone pattern brick pavement.
