DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small 2-1/2 story frame house detached on the right side and two bays square with a full width, two story frame wing four bays long with a rear balcony and a one story, one bay square frame extension. It is covered by asbestos shingles. The front door occupies the right bay with panels and a two pane overlight. Front windows are of 2/2 sash and protected by louvered shutters. Side windows are of small 6/6 sash, and there is a four panel door with an overlight on the rear. The attic is lighted by a small 6/6 sash in the right gable. The front section has moderate slope "A" frame roof with an enclosed chimney on the left side and the wing has a shed roof and both are of metal. Rooflines are enclosed by plain boxed cornices. The building rests on a street level foundation and is fronted by a herringbone pattern brick pavement.
