DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#244 is a 2-1/2 story log building, four bays wide and two in depth with an "L" shaped brick, two story wing with a side balcony and a newer, one story, brick store addition below which makes the first floor plan rectangular. The front and left side facades are now covered by wood siding in a carved "stone block" design with superimposed wood "quoins" at the corners. The right side is now exposed by the removal of an adjoining building and clearly displays large, split logs and holes for pegs.

The first floor is now lighted by large, plate glass shop windows and a center door. All upper front section windows are of 2/2 sash with louvered shutters except for a small, four pane attic window in each gable.

The front roof line is ended by a boxed cornice and decorated by a dentiled frieze. The only visible chimney is enclosed in the right side of the wing.
