DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A three bay wide, four bay deep, three story, flat-roofed, Victorian structure, built probably as a shop with apartments above, the first story windows are 2/2 sashes and a recessed door occupies the east front bay. The second story windows are long 6/9 sashes and open onto a cast iron balcony which runs along the whole front of the house. This, doubtlessly, was the parlor floor of the structure. The third floor has 6/6 sashes similar in size to the windows on the first floor. All the windows and the door on the front of the building have moulded and bracketed Victorian wooden cornices. There is a heavy wooden, bracketed cornice along the front of the roofline with a broad frieze decorated with moulded panels.

There are two chimneys enclosed in the west end wall of the structure. There are much lower two story, flat roofed additions to the rear of the main building.

It is said that this building was a coffin factory during the Civil War after several nearby battles, notably Antietam and Gettysburg.

It is in fair condition and should be preserved for its historical importance and also for the architectural character it adds to Patrick Street.
