DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A nicely proportioned cut fieldstone double house of the mid-Georgian period. It is 2-1/2 stories in height, four bays wide and three deep with an "A" frame roof which slopes steeply from front to rear. There are no visible chimneys left on the edifice. The two central first floor bays are occupied by doors with overlights. All the windows are replacement 2/2 sashes. The first floor windows and doors have flat arches of cut stone. The second floor windows are almost flush with the roof line and have very rough stone arches. There is a simple moulded wooden cornice along the front roof line. The two doors are nineteenth century ones. The house is made of very nicely cut stone blocks and has a protruding stone watertable. There are high basement windows with flat stone arches.
