A Federal townhouse of very good solid proportions, it is 2-1/2 stories in height with an "A" roof which slopes moderately from front to rear. It is three bays square and sits on a high fieldstone foundation with a slightly protruding stone watertable. There is a double chimney with a curtain enclosed in each end wall. There is a three string brick cornice along the front roof line. The house is made of very neatly laid common bond brick. A door with an overlight occupies the west front bay. All the windows are 6/6 sash with stone sills and stone lintels with larger square end blocks incised with roundels. A typical Federal detail in this area.
