DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A rather unusual, late Federal structure, this building is six bays long, two bays deep, and 2-1/2 stories in height with a rather moderately pitched "A" frame roof. The house now has a Victorian storefront on part of its first story. The easternmost bay is occupied by an areaway. The next three bays are occupied by a shopfront--an attractive Victorian one with a bracketed cornice and old shop windows. The west front first floor bay is occupied by a 6/6 window with a wooden lintel. The second bay from the west is occupied by a door with an overlight. It is reached by a flight of sandstone steps with a cast iron railing.

The second story has six 6/1 sashes with wooden lintels. There is a three string brick cornice along the front roof line. There is a large chimney enclosed in the east end wall of the house.
