DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A small, simple, late Federal style, common bond brick, 2-1/2 story house with a moderately pitched "A" roof which is in excellent condition, it is four bays wide and two bays deep. All the windows are 2/2 sash with stone sills and lintels. The front door occupies the second bay from the east. It is reached by a flight of six granite steps with a cast iron rail.

The door has a rather heavy machine-cut Victorian wooden frame with cut brackets and a row of dentils. There is a three string brick cornice along the front roof line and a chimney enclosed in each end wall of the house.
