DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three story Victorian era structure is occupied at the first floor level by the Frederick Union Rescue Mission and on the upper floors by dormitory rooms.

Of painted brick, common bond construction, it is six bays wide and eight bays in depth. A difference in the facade treatment of #200 and a visible zig-zag seam in the brickwork, indicates a slightly different construction date of the two sections.

A late Victorian shop front extends across the whole of the first floor level (designed for a grocery store). The entablature is decorated with carved modillions and dentils and with pierced sunburst motifs in the frieze. Pilasters of vertical and diagonal reeding frame the window and side entrance areas.

Centrally positioned on the facade of #200 in the upper stories are recessed panels containing the windows headed by corbeled cornices. All windows are of 1/1 sash. Windows on either side are headed by segmental arches. Second floor windows of #202 are of 4/1 sash with flat brick arches. Those on the third floor are of 1/1 sash with segmental arches.

A protruding cornice heads the north and west facades and is adorned with closely spaced brackets.

A cantilevered leaded glass marquee of around 1900 heads the entrance in the eastern bay.

The roof slopes gently to the rear. The building rests on a low foundation.
