DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick attached building three bays wide and approximately five bays long. This is joined by an "L" shaped extension two bays wide and three bays long. All brickwork is in common bond. The first floor is occupied by two shops with large plate glass windows, however, Sears, the larger shop, has been changed to a modern colonial design in woodwork with natural brick bases and a carriage lamp. Upper story windows are of 1/1 sash with wood lintels and sills and those on the third stories have slightly projecting cornices. There are no rear area windows. The metal roof slopes to the rear with a stepped wall and enclosed chimney on the right. The front cornice is similar to that of #4 & #6 with simple moulding and dentil trim. The building rests on a low foundation.
