DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three story brick attached building is approximately three bays square with a one bay wide, three bay long, two story brick "L" shaped wing with a side balcony. Front brickwork is laid in painted Flemish bond and that of the rear areas is in common bond. The front facade has "modern" shop windows and entrances with large panes. A moulded cornice with dentil trim unites the first floor features. Upper story front windows are of 1/1 sash with moulded lintels. Rear area windows are of 2/2 sash with wood lintels and sills. The roof of the front section slopes to the rear with a covering of tarred stone. There are enclosed chimneys on the right wall and on the wing. The front section roof is enclosed on both sides by built-up walls extending back from the front, and is "supported" on the rear by a three string brick cornice, unusual for a flat roof, but possibly used for a former "A" frame roof. The front cornice line is of the same design as on #9 with simple moulded construction, modillions decorated with bosses in a rose motif and a raised brick frieze with a moulded bar. The building rests on a low foundation.
