**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a large, three story brick detached building on a corner. It is three bays wide and approximately four bays in depth with a lower three story full width three bay long wing with a third floor side balcony and a three story wooden extension one bay long and two bays wide. The entrance to the apartments occupies the left front bay while the other two bays contain a modern shop entrance with large plate glass windows on either side. A simple moulded cornice crosses the first floor level above the entrance and the shop area. Upper story windows are either 2/2 or 2/1 sash and 2/2 or 6/1 sash on the sides and rear. Moulded hooded cornices crown the front windows. Front brickwork is laid in painted Flemish bond to the second story level and the sides and rear are in common bond. The roof of the front section slopes slightly to the rear and those over the wings slope to the side. The left wall is stepped above the roofline and two enclosed chimneys rise from the left side. A moulded, protruding cornice on the front is supported by four large scrolled brackets, fluted and trimmed with rose motifs on the bosses and endings. In between is a row of large dentils. The building rests on a low foundation.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This three story brick dwelling, painted gray, was built in approximately 1820 and was known as the Walker property. There are two wide interior chimneys on the west side of the building. There are three 2/2 windows on each of the second and third floors, the third floor having been added at a later date than the first two stories. Above each of the windows is a shelf or entablature type cornice. The cornice at the roofline of the shed-type roof is a boxed cornice with brackets.

There is a commercial occupancy on the first floor of this building.
