**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is now a three story brick building presently detached on the right side. It is four bays wide, approximately four bays deep, has rear balconies, and two long two story brick extensions to the rear. All brickwork is of common bond. The first floor has been altered considerably with a large paned glass shop front and a small apartment entrance to the left. This was probably built as a 2-1/2 story Federal house but no visible evidence remains. On the right bay is a bay window unit for the second and third stories and has 1/1 sash, panels, and Victorian cornices with dentil trim. Other upper story windows are of 6/6 sash with moulded lintels and sills. The low attic is lighted by small four pane windows on either side. The building has a low slope "A" frame metal roof with a small enclosed chimney in the right gable. There is a protruding Victorian cornice at the roofline with deeply moulded brackets trimmed by small pendants and with a wooden frieze moulded on the bottom edge. This building rests on a high fieldstone foundation.
