DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick semi-detached building two bays wide and nine bays long. It sets back from the street with the gables at a right angle to it. This had originally been "Eberts Carriage House" with a front elevator storing carriages on the second floor. A picture of the original facade hangs in Delphey's Sports Shop. The basement fieldstone walls are very thick and supported wide band beam timber floor joists, some still containing the bark. The front facade was rebuilt in the early part of the 20th century of beige brick in common bond of two stories with a stepped parapet. A front shop window of one bay square and one story in height projects out to the pavement line. The old side windows on the second story are of 6/6 sash with wood lintels and sills. The metal "A" frame roof is very steep and rests on a two string brick cornice on both sides. The building rests on a rather high fieldstone foundation.
