**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story brick attached building, three large bays wide and approximately two bays in depth with an "L: shaped three story wing two bays wide and five bays long. To this is added a two story long extension. There are rear balconies on the remaining bay of the front section. The entire front facade has been rebuilt with small tan colored face brick, contains 1/1 sash with metal lintels, and all is in common bond. The first left bay is angled to the rear to blend with the setback of #140A. Rear area windows are a combination of modern types. The roof of the front section slopes to the rear with stepped sidewalls and the wings have shed roofs-- all of metal. There are numerous small chimneys on the right wall. A Victorian style roof cornice overhangs the wall and is composed of closely spaced carved modillions and ended by carved bosses in a rose motif. The row of long dentils tops the frieze and just below this, the center of the wall is a nameplate of the owner in colored tiles. The building rests on a low foundation.
