DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick house detached on the right side and approximately three bays square. It has an "L" shaped three story (formerly two story) brick wing six bays long and two bays wide with a long side porch and balcony overhead. To this is added a one bay square, two story extension. All brickwork is of common bond and the front facade is faced with painted pressed brick. A tall, impressive entranceway occupies the left bay and is of Federal design with double doors, paneled and round arched, topped by a four pane overlight and framed by Doric pilasters and a flat entablature. This is approached by two granite steps and leads to a spacious vestibule wider and taller than the entranceway and with three more steps to the inner pair of double doors. These doors are paneled with the center ones carved in floral designs. On either side are one pane lights over panels and over all is a seven pane overlight. Sidewalls have recessed moulded panels and the ceiling has a large moulded panel with a projecting floral moulding in the center and smaller floral motifs in the corners. All front windows are now of 1/1 sash with flat brick arches of shaped voussoirs. There is a JIB (Federal) window-door on the first floor rear of the front section and all rear windows are of 6/6 sash with wood lintels and sills. Doors are paneled with four pane overlights. The front section roof is of a low slope "A" frame with wide enclosed chimneys on each side of the gables. This roof is supported on t' front by a two string "Federal" brick cornice with wood moulding below, making it appear to be four string. On the rear is a three string cornice. The wing has a shed roof and both are of metal. The house rests on a very high foundation.
