DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house attached to buildings on either side as it occupies a former alleyway to the side of #147. It is one bay wide and two bays deep with a rear balcony. There is a more recent one story cement block extension of the first floor. Brickwork is of common bond. The front has a modern shop, now closed. On the second story front are two closely spaced 6/6 sash windows with wood lintels and sills. On the rear is a small dormer window of four panes. There is also a 4+4 sliding sash on the second story with wood lintels and sills. There is a glass over panels rear door. The moderate slope "A" frame roof, joining that of #147, rests on three string brick cornices on the front and rear and the house uses one of the double flue chimneys on the #147 side.
