DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick attached house, three bays square, with a two story brick "L" shaped wing two bays wide and four bays long with a one bay long extension. All brickwork is in common bond. The entranceway occupies the left bay and consists of a paneled door with a Victorian style overlight of triangular panes and enclosed by Doric pilasters and a high flat entablature. Second story front windows are of 6/6 sash with 1/1 sash below and all have wood lintels with square end blocks carved with roundels. Rear area windows are either 6/6 or 6/1 sash with wood lintels and sills. A rear door is paneled and has a three pane overlight. The front section has a moderate slope "A" frame roof with an enclosed chimney on either side of the right gable (one serving the adjoining #145). The wing has a flat roof and both are of metal. Front and rear rooflines are supported by three string brick cornices. The building rests on a rather low fieldstone foundation. There is a long flower yard to the rear.
