**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick house detached on the left side and approximately three bays square. It has a two story brick "L" shaped wing approximately one bay wide and four small bays in depth with an extension of two small bays in depth. All brickwork is in common bond. The entranceway occupies the right bay and consists of a glass door with a Victorian style overlight of triangular panes and enclosed by Doric pilasters and a high flat entablature, somewhat similar to that of #147. Second story front windows are of 1/1 sash with wood lintels and square end blocks carved with roundels as on #147. Rear area windows are also of 1/1 sash but with some newer metal casements. A rear door has glass over panels and a three pane overlight. The front section has a moderate slope "A" frame roof with enclosed chimneys joined by a curtain on either side of the left gable, and the wing has a shed roof--both of metal. Front and rear rooflines are supported by three string brick cornices. A small six pane window lights the attic from the left gable. The building rests on a rather low fieldstone foundation. There is a long flower yard to the rear.
