**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story brick building detached on the right side and is four narrow bays wide and approximately three bays deep. It has an "L" shaped, two story brick wing two bays wide and six bays long with a side balcony on the first and second floors. The basement is mostly above ground level because of the nearby creek to the rear. The wing is positioned at an angle to conform to other nearby buildings. Front brickwork is laid in Flemish bond with a moulded brick watertable and with evidence that a belt course at the second story level was chipped off. Rear area brickwork is in common bond. According to sidewall evidence, this was built as a 2-1/2 story house. An entranceway occupies the right bay and has a rather new paneled door but with a four pane overlight and framed by Doric pilasters and a flat entablature. It is approached by a four step cement porch and has a time-worn stone doorsill. Front and rear windows are all of 6/6 sash with wood lintels and sills with the front lintels decorated by Victorian moulding and a cut motif. Rear doors are either of glass over panels or newer types, but all with overlights. The front section roof slopes to the rear with stepped walls and the wing has a shed roof, both of metal. The projecting front roof cornice has carved modillions fronted by bosses with a floral motif and a moulded bar runs across the center of the raised brick frieze. The rear cornice is of three string brick, unusual for this type third story roof. The building rests on a high field-stone foundation. There is a pleasant tall tree shading the back yard, but it is no. rather neglected.
