DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached pair of houses four bays wide and approximately three bays in depth with two story brick "U" shaped wings about 1-1/2 bays wide and about 5' between them. #155's wing is four bays long with a side balcony and #157's is two bays long. Front brickwork is laid in painted Flemish bond and other areas are in common bond. There is a three string belt course crossing the front at the second story level, but no evidence of a watertable. Front doorways, now boarded over, are located in the first and third bays from the right and are of simple construction with wood lintels and low stoops. Front and left side windows are boarded over but remaining ones are of 2/2 sash with wood lintels and sills. The attic is unusually well lighted by two 6/6 sash, stepped top dormers on the front, a small peaked dormer on the rear, and two small four sash windows in each gable. There remains a paneled door on the rear. The front section has a moderate slope "A" frame roof with wide enclosed chimneys at each gable. The wings have shed roofs and all are of metal. The front cornice is of very simple moulding with dentil trim. The building rests on a low fieldstone foundation.
