**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick building detached on the left street (corner) side. It is three bays wide and two bays in depth with a two bay wide, three bay long, two story cement block wing at an angle conforming to the side street. All brickwork is in common bond. On the first floor is an old central entranceway with double doors of glass over panels and a paneled enframing, topped by a low, four pane over light with moulded transom bar and a wood lintel. To either side is an old rectangular bay shop window of 4/4 sash, supported on brick walls. This building is said to have been an early tavern. Second floor front windows are of 6/6 sash with wood lintels and sills and louvered shutters. The front section has a moderate slope "A" frame roof and formerly had a small enclosed chimney in the left gable (now heated from adjoining #202). The front roofline is supported by a three string brick cornice. The building rests on a low foundation and is fronted by a herringbone pattern brick sidewalk.
