**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a tall, two story brick building three bays wide and two bays deep with a later commercial, one story brick extension of full width and six bays long. All brickwork is of common bond. The first floor is occupied by a modern shop entrance with large pane windows covered by an attractive moulded cornice across the building. The second floor front has 6/1 sash with flat (perpendicular) brick arches. There are no longer rear windows. The roof of the front section slopes to the rear, no chimneys are visible, and the wing has a shed roof, both of metal. The front roofline has a Victorian style cornice of a  shape of moulded wood with dentil trim. The building rests on a low founda- tion.
