DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#207 is a very large, detached brick townhouse, three large bays square, 2-1/2 stories in height with a 2-1/2 story brick "T" shaped with, three bays in depth and two bays wide with balconies on both sides and the rear. All brickwork is in common bond. The front entrance occupies the center bay with double doors of glass, wide transom, and a dentiled transom bar. This is approached by a three step stoop of concrete, but resembling granite, which is also used for all first and second story window lintels and sills and for facing the foundation. House windows are of varying width and of 1/1 sash with those on the first two stories having louvered shutters. The right section of the front facade contains the recessed doorway joined by a two story brick bay window section. The front section has a steep slope "A" frame roof with the ridge running front to rear and the front gable is of a hipped shape with a centered shed roofed dormer window and a pedimented dormer window section on either side containing pairs of windows. On each side, at the end of the front section, is another larger pediment containing a small Paladian design window section. The wing also has a steep sloped "A" frame roof with the ridge running from front to rear. This building sets on a high foundation. The brick pavement is in a herringbone design. All roofing is of a diamond shaped, tile like material and a wide overhang projects on all four sides of the building.
