DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story house with a street level basement and detached on the right side. It is said to be of fieldstone construction by C.F. Bowers, local architect-historian, but the front is covered by formstone and the exposed side by stucco. There is a watertable still discernible. It is four bays wide and three deep with a two story brick "L" shaped wing angled to the front section to conform to lot lines of this block. This is two bays wide and four bays long with a side balcony. There is an entranceway in the left bay with a small panel door and a transom with two rows of small panes. All front and rear windows are of 6/6 sash with those on the wing showing wood lintels and sills. On the front facade, there is an old door with glass over panels in the right bay leading to the basement. The second story window in the left bay is of greater spacing. The front section has a moderate slope "A" frame roof with a small enclosed chimney on the rear of the left gable. There is a plain boxed cornice on the front and rear rooflines. The attic is lighted by a small window in the right gable. The wing has a shed roof and both are of metal. The front entrance is approached by eight steps. There is a long yard to the rear-- now neglected.
