DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#208 is a brick, three story house, detached on the left (N) side and is three bays wide and two bays in depth with a two story "L" shaped wing, two bays wide and five bays in depth with a two story, one bay square frame extension and balcony. All brickwork is in common bond. A tall, round arched doorway occupies the left bay with a Victorian paneled door and the whole is framed by a wide moulded architrave. To the right is a large elliptically arched triple window of 1/1 sash with mullions adorned by grooving and headed by attached spheres. Transoms are enclosed within the arches with colored stained glass partly in wood muntined small panes and with dentiled transom bars. Upper story windows are of 2/2 sash as on the rear and with segmental brick arches. Rear area windows have two row segmental brick arches on the first floor and wood lintels and sills on the second story. The front roof slopes to the rear and the wing has a shed roof. The front roofline is decorated by a Victorian cornice carried across to #210-212 and is adorned with rows of scallops, dentils and beading. The bays are divided and ended by ornate brackets bearing miniature pillars and beading. The house sits on a high brick faced foundation.
