DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of attached houses being five bays wide and two bays in depth with an "L" shaped, two story brick wing and that being four bays wide and two bays in depth, and a two story, four bay wide and two bay deep extension with a rear balcony and angled to the first wing to conform to property lines of this block. All brickwork is in common bond. Front entranceways occur in the first and fourth bays from the left with Victorian style glass paned doors, one pane transoms, and wood lintels with the door and window of #231 decorated with added wooden, flat pediments. In the right bay is an enclosed passageway with a decorative wood grill above. Three string brick cornices support the front and rear rooflines. All front windows are of 1/1 sash. There is a 2/2 sash on the rear of the front section and others are either 6/6 or 1/1 sash and all have wood lintels and sills. The front section has a moderate slope "A" frame roof with a square chimney rising from the center rear.
