DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large 2-1/2 story brick pair of homes detached on the left side and five bays wide by three bays deep with 2-1/2 story "U" wings. These are two bays wide and four bays long with #239 retaining its side balcony. All brickwork is in common bond and the exposed top of the right side shows this wall to be of fieldstone. Entranceways are in the second bay from each end and have doors of six panels with paneled enframements, three pane overlights and moulded transom bars with dentil trim. The center bay has an enclosed passageway to the rear yards and is fronted by a pair of old paneled gates with a paneled enframement and a four pane overlight. On the rear of this passageway is a very wide and heavy wood lintel. First floor front windows are tall 1/1 sash and those on the second story are of regular 6/6 sash, all with moulded top wood lintels as over the doors and passageway. On the rear of #241 is a large 12/12 sash window, but all others are 6/6 sash with wood lintels and sills and either paneled or louvered shutters. The front section attic is lighted by small 6/6 and the wing attics by 6/3 sash in the gables. Rear doors are paneled and have three pane overlights. The roof of the front section is a moderate slope "A" frame with wide enclosed chimneys on each gable. The wings have steep slope "A" frames and all roofing is of asphalt shingles. The front cornice is of Victorian vintage and with an overhanging box structure supported by closely spaced scrolled brackets and adorned by turned pendants. The rear roofline has a plain boxed cornice. The building has a very high fieldstone foundation with six steps to the entrances.
