DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story frame pair of houses detached on the right side except for a one story frame fill-in section. It is four bays wide and two bays in depth with a full width, two bay deep extension. This clapboard covered building has a front facade laid in Flemish bond brick which extends back on the sides about four feet. Entranceways are in the inner bays and now have glass over panels doors with one pane overlights. A wide cement covered stone stoop with low end walls extends completely across the front. All front windows are now of 1/1 sash with wood lintels and end blocks carved with roundels as over the doors which are side by side and covered by one long lintel with one block in the center. Rear and side windows are of small 6/6 sash. The front section has a steep slope "A" frame roof of metal joined by a shed roof covering the extension. A double flue chimney rises from the center of the ridge and there is another smaller one on the end of the extension. The front roofline rests on a three string brick cornice. This building sets on a low fieldstone foundation and is fronted by a brick sidewalk.
