DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick pair of attached houses, five bays wide with #212 occupying three bays, and two bays in depth with a "T" shaped 2-1/2 story brick wing four bays wide and five bays in depth with #210 having a side balcony and #212, one on the rear. All brickwork is in common bond.

Simple round arched entrances occupy the outer bays with small paneled doors, white marble sills and moulded transom bars. Narrow board and batten gates with incised scrollwork grills above are located at each end and lead to enclosed passageways to rear yards. First floor windows are double with 1/1 sash, lugsills, and are headed by flat brick arches of long shaped voussoirs. Upper story front windows are segmental brick arched with 2/2 sash as on the rear wall. The wing area has 6/6 sash with wood lintels and sills. The front section roof slopes to the rear and the wing has a moderate slope "A" frame roof covered by asphalt shingles. The front roofline is decorated by a Victorian cornice with rows of scallops, dentils and beading. The bays are divided and ended by ornate brackets bearing miniature pillars and beading. This cornice continues across #208. The building sets on a low foundation.
