DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a very low, 2-1/2 story brick building attached to the buildings on either side and is one bay wide and three bays deep with a one story block extension being six bays long. This is a fill-in, probably of an early driveway, and is said to have been built as a kitchen for the mansion to its left. However, the confusing aspect of it is that its neighbor to its right is of late 19th century architecture style unless it was an original wall of a former building on its right. All brickwork is of common bond. This is now an antique shop on the first floor and has a wide pair of old double doors with glass over panels and a six pane overlight topped by a heavy wood lintel. On the second story is a 6/6 sash with wood lintel and sill. There are no original rear fenestrations. It has a moderate slope "A" frame roof with corrugated metal covering but no chimney. It has a very low foundation. The recently restored front facade shows it to have a light salmon brick construction.
