**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick detached house, four bays wide and two bays in depth with a two story brick, two bay wide, three bay deep "L" shaped wing with a side balcony and rear balcony on the exposed front section. All brickwork is of common bond. There is a small Federal doorway in the second bay from the right with a six paneled door, a paneled enframement and a four pane overlight. Front windows are of 6/6 sash with grooved wood lintels (unusual) and square end blocks carved with roundels. Side windows are of 6/6 sash or 2/2 sash with regular wood lintels and sills. One wing door has four panels and a four pane overlight. The front section has a steep slope slate roof with an enclosed double flue chimney at each gable and is supported on the front by a two string brick cornice. The wing has a metal shed roof with an enclosed chimney on the right center. The attic is lighted by small windows in the gables. This building rests on a rather low fieldstone foundation.
