DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large 2-1/2 story brick house detached on the right side and is five bays wide and approximately three bays in depth with a new one story block extension three bays wide and two bays deep centered on the rear. The front facade is stuccoed and all visible brickwork is in common bond. A watertable crosses beneath the first floor windows. The central entranceway has an old six paneled pair of doors with the top sections now in glass. There is a paneled enframing and a four pane overlight. All windows are of 6/6 sash but those on the rear have new metal lintels and brick sills. The metal roof has a moderate slope "A" frame with wide enclosed chimneys at each gable. The attic is lighted by a large window on the right side. There are wooden boxed cornices on both the front and rear rooflines, but the front is decorated by small pendant, evenly spaced globes. This building rests on a rather high field-stone foundation.
