DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, two story pair of brick houses detached on the right (N) side and are approximately three bays in depth with two story brick "U" shaped wings 1-1/2 bays wide and two bays in depth and angled to the front section. #209 also has a two bay deep brick rear extension and rear balcony, with #211 having a two bay deep frame extension. Front brickwork is of a dark red pressed brick and all is in common bond. Round arched doorways occupy the outer bays with period doors, dentil transom bars and these arches are trimmed with white marble impost blocks and keystones, as are front windows. These are entered by concrete porches with wrought iron railings. Bay windows with dentil trim are cantilevered above the doorways and in between are 1/1 sash round arched windows, as below. Rear windows are of 2/2 sash with wood lintels and sills. The front section roof slopes to the rear and the wings have shed roofs. The roof cornice is decorated by bands of incised motifs, dentils, and mouldings, and brackets separate and end the houses. This building rests on a low fieldstone foundation.
