

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large 2-1/2 story brick building detached on the left side and being four bays wide by approximately three bays in depth. It has a two story brick "L" shaped wing two bays wide and five bays long with long side and rear balconies. The first floor of this wing has been extended out under the balcony and has a long cement block extension for funeral home use. The front facade is laid in Flemish bond brick and all other is in common bond. There is a moulded brick watertable at the base of the front windows and a five string belt course crossing beneath the second story windows. This is ^{an} the cross  motif as on the NE corner of Third and Market Streets. The entrance way is in the second bay from the right and has a deep vestibule fronted by a pair of glass and wood doors with a round arched transom. This is approached by cast iron steps with decorated balusters. To the right is a wide round arched, former carriage entrance topped by a three row brick jack arch and with a three brick voussoir keystone. All front windows are now of 1/1 sash with those on the first floor having round arched transoms like the doorway and three string brick header hoods with each row recessed under the other and with voussoir keystones like over the doorway and gateway. Second floor windows have segmental two row header arches with similar keystones. Rear area windows are either 6/6 or 1/1 with the rear of the front section having both flat and segmental brick arches and the wing has wood lintels and sills. The front section has a moderate slope "A" frame roof with no chimneys and the wing has a shed roof--both being of metal. The attic is lighted by a large 1/1 sash window from the left gable. There is a mullioned wood cornice at the front roofline. The building reposes on a rather high fieldstone foundation.
