DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick corner building approximately three bays square with an "L" shaped, two story brick wing approximately 1-1/2 bays wide and three bays deep with a street side, two story, frame extension making the wing full width. This building also has a one story, one bay square, rear extension. All brickwork is in common bond. The first floor front had been converted to a shop with a wide three section window with a moulded cornice and an entrance in the left bay. This has a glass over panels door, paneled enframement, and a transom. This is headed by a moulded flat entablature. Second story front windows are now of 1/1 sash with wooden lintels having moulded tops. Original rear windows are of 2/2 sash with wood lintels and sills. The front section has a moderate slope "A" frame roof with a wide enclosed chimney on the right side and is supported by a three string brick cornice on the front and a two string cornice on the rear. The attic is lighted by a 1/1 sash on the exposed left side. The wing has a shed roof and both are of metal. The front porch has a decorative cast iron railing. The building rests on a rather high foundation.
