DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick corner building being four bays wide and approximately three bays in depth. There is a two story brick "L" shaped wing added at a later date which is five bays long, the first two bays being four bays wide and the last three bays being three bays wide with an end balcony. There is also a one story frame extension. The front brickwork is laid in Flemish bond, painted, and all other is in common bond. A shop occupies the first two bays from the corner with an angled entrance containing a glass over panels door and with large pane shop windows to the left and right. #303 has a six panel door with the top panels in glass and an overlight with a wood lintel. All windows are now of 1/1 sash with wood lintels and sills. Rear doors have glass over panels. The attic is lighted by a 6/6 sash from the right gable and by a 6/6 peaked dormer on the rear of #303. The front section has a steep slope "A" frame roof with a wide enclosed chimney rising from the left gable and the wing has a shed roof, both of metal. The front roofline rests on a three string brick cornice. The building sets on a low foundation.
