DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small 2-1/2 story brick attached house approximately two bays square with a two story brick "L" shaped wing 1-1/2 bays wide and five bays long with no balcony. Front brickwork is laid in Flemish bond, painted, and all other is in common bond. The entranceway occupies the left bay with a new door, a three pane overlight, and the transom enframement paneled. This is headed by a flat brick arch as are the second story front windows. The first floor window is a large 1/1 sash with a segmental two row header brick arch and all have louvered shutters. Second floor front and all rear windows are of 2/2 sash with rear windows headed by one or two row brick header arches. Rear doors have glass over panels and with overlights. The attic is lighted by a small four pane sash in the right gable. The front section has a rather steep "A" frame roof with a small enclosed chimney rising from the right gable and the rooflines are supported by three string brick cornices on the front and rear. The wing has a shed roof and both are of metal. The building rests on a low fieldstone foundation.
