## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is now a one story attached frame house, possibly a former shop built as an addition to #304-1/2 on the right. It is two bays wide and four bays long with a small extension. The front is now sheathed in aluminum siding and the rear in asbestos shingles. The front doorway occupies the right bay with small glass panes over panels and the front window has a 6/1 sash while on the rear is a 6/6 sash and a small casement window. The entire metal roof slopes to the rear and there is no chimney. The front has a very elaborate Victorian cornice, quite massive for such a small building and has square moulded panels with centered roundels and separated by turned spindels. This is topped by a row of projecting roundels and with large carved brackets on each end. The building rests on a very low foundation.
