DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a brick 2-1/2 story separate home, a later extension of #301-303, and it is attached on both sides. It is two narrow bays wide and approximately three bays in depth with no wing or balcony. All brickwork is in common bond. The doorway occupies the right bay with a six panel door with the top panels in glass and there is an overlight. The two front windows are now of 1/1 sash with wood sills and lintels as over the door. Rear windows are 6/6 sash with wood lintels and sills and there is a four paneled door with an overlight. The attic is lighted by a 6/6 peaked dormer on the rear and by a small window in the left gable. The front section roof is a continuation of the steep slope metal "A" frame of #301-303 and there is a small enclosed chimney rising from the left side. This roof is supported by a three string brick cornice on the front and by a two string on the rear. The building sets on a low foundation.
