DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a narrow 2-1/2 story frame house detached on the left side. It is a narrow two bays wide and approximately three bays in depth with a smaller two story frame, two bay square wing. All wood is covered by asphalt shingles. The entranceway occupies the right bay with a decorative door containing a large oval sash with raised scrollwork in the spandrells. Front windows are small 2/1 and 1/1 with real windows being small 6/6 and 2/2 sash and a glass over panels door. The attic is lighted by a small window in the left gable. The front section has a moderate slope "A" frame roof with a small enclosed chimney rising from the left gable, and the wing has a shed roof with both being metal. The front roofline has a very simple boxed cornice. This building sets on a low foundation.
