DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story frame pair of houses, four bays wide and two narrow bays in depth with two story "U" shaped frame wings, 1-1/2 bays wide and four in depth. #309 is covered by wood siding and #311 by metal siding on all sides. Entranceways occupy the end bays with six panel natural finish doors and with one pane segmental arched overlights. All front windows are of 1/1 sash with segmental arches and louvered shutters with those on the first floor being wider. In the center, between the windows, is a narrow enclosed passageway to the long rear yards and this has a decorative, cut-out grill at the top. Rear windows are also of 1/1 sash but with flat arches, and there are newer doors. The attic of #309 is lighted by a 6/3 sash in the right gable. The front section has a low steep slope "A" frame roof with a square chimney rising from the center of the ridge. The wing has a shed roof and both are of metal. The front roofline is adorned by a simple boxed cornice with a dentiled frieze and has small fluted end brackets. The building rests on a low fieldstone foundation.
