DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the left side. It is four bays wide and two bays in depth with a two story brick "L" shaped wing, one bay wide and two bays long with a side balcony. All brickwork is in common bond. The doorway occupies the second bay from the right and has a door with modern panels and a carved overlight. Front windows are of 6/6 sash with wood sills and lintels having square end blocks carved with roundels. Most rear windows are of 6/6 sash except the rear wing wall with a small four pane and 4/2 sash, and all have wood lintels and sills. There is an old glass over panels door. The front section has a moderate slope "A" frame roof resting on two string brick cornices on the front and rear with a double flue chimney rising from each gable. The wing has a shed roof and both are of metal. The building sets on a low fieldstone foundation.
