DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the right side, and it is approximately three bays square with an "L" shaped 1-1/2 story brick wing, 1-1/2 bays wide with a long overhanging metal shed roof and four bays long. All brickwork is in common bond. The entrance occupies the left bay with a glass over panels door and a rectangular transom with a wood lintel. First floor windows are of 1/1 sash with 6/6 sash on the second story and all with wood lintels and sills. Rear windows are also 6/6 sash with wood lintels and sills and there are four paneled doors with four pane overlights. The attic is lighted by two small windows in the right gable. The front section has a steep slope metal "A" frame roof with a double flue enclosed chimney rising from the right gable. This is supported by three string brick cornices, both front and rear. There is a long lawn area behind the house. This building sets on a low fieldstone foundation.
