DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small 1-1/2 story brick detached pair of houses, four bays wide and two bays in depth with a one story and "A" frame attic "T" shaped frame wing approximately three bays square and covered by asbestos shingles. All brickwork is in common bond. Front entrances occupy the inner bays with four panel doors, paneled enframements, and four pane overlights. First floor windows are of 6/6 sash and the top 1/2 story has one pane casement "beebrow" windows on the front and rear. All front windows have wood sills and lintels with square end blocks carved with roundels, as over the doors. The wing has 2/2 sash. The front section has a moderate slope "A" frame roof supported by three string brick cornices on the front and rear with an enclosed chimney rising from each gable. The wing has a steep slope "A" frame roof and both are of metal. This building rests on a low foundation (fieldstone). It is fronted by a brick pavement. There is a long yard to the rear.
