DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#214 is a three story brick house attached on both sides and is four bays wide and two bays in depth with a two story brick "L" shaped wing 1-1/2 bays wide and six bays long with a side balcony and newer side frame extensions. All brickwork is in common bond. A round arched doorway occupies the left (N) bay with double doors of panels, while marble sill and an ornate transom bar is a cross design. This leads to a vestibule with double doors and a similar transom bar. All front windows on the first floor are of 1/1 sash with 2/2 sash on the upper floors and the rear wing area. These have segmental brick arches on the front and wood lintels and sills on the rear. The right bay contains a board and batten gate with an overhead Victorian cut grill leading to an enclosed passageway for the rear yard. The front section roof slopes to the rear and the wing has a shed roof. The front roofline is decorated by an overhanging Victorian cornice area with closely spaced, fluted modillions, and bands of triglyphs, pierced spheres, and crosses similar to over the front door. Large grooved cyma curved brackets ended by foliated motifs divide and end the bays with panels in between on the frieze. This house rests on a low fieldstone foundation. To the rear are landscaped gardens with fieldstone paths, a fish pond, and seasonal flowers.
