**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick detached house being three bays wide and two bays in depth with a two story brick "L" shaped wing being two bays wide with a side balcony and three bays long with a three bay extension and a later addition on the end. Front brickwork is laid in Flemish bond, painted, and all other is in common bond. The front entranceway occupies the left bay and has a more modern glass and panels door, a paneled enframing and a three pane rectangular transom. A modern covered porch with cast iron (New Orleans style) supports in a floral pattern extends across the front. All front windows are now 1/1 with wood lintels and square end blocks carved with roundels. Rear area windows are of 6/6 sash with wood lintels and sills. Rear doors have glass over panels with three pane overlights. The attic is lighted by two 4/2 sash in the left gable and one 4/2 on the right. The front section has a steep "A" frame roof covered with slate and double flue enclosed chimneys rise from each end. This roof rests on three string brick cornices on the front and rear. The wing and extensions have metal shed roofs. The house rests on a street level fieldstone foundation.
