DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#215 is a 2-1/2 story brick detached house, three bays wide and two bays in depth with a 2-1/2 story frame "L" shaped wing two bays wide and four bays in depth with a side balcony and small brick dependency. All brickwork is in common bond. The front entrance occupies the right (N) bay with a four panel door, top panels rounded; white marble sill; and a moulded transom bar. All house windows are of 2/2 sash with wood lintels and sills and those on the front have louvered shutters. The kitchen and dependency both have old, thin paneled doors. The attic is lighted by a small, four pane window in the right gable and the rear of the wing.

The front section has a moderate slope "A" frame roof resting on three string brick cornices and a double flue enclosed chimney rises from the left side. The wing has a steep slope "A" frame roof and both are of metal. The house rests on a low fieldstone foundation. It is fronted by a herringbone patterned brick pavement.
